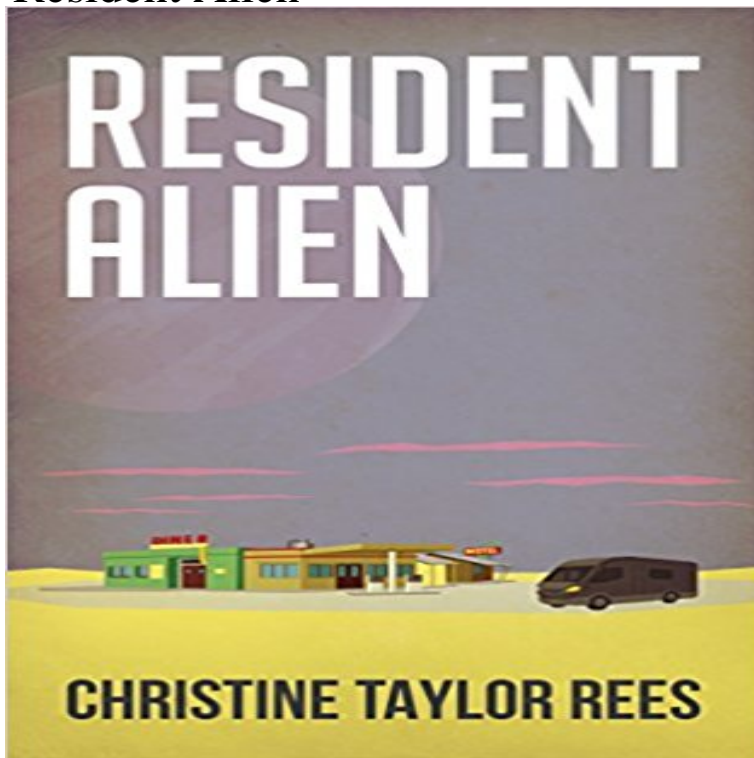


Resident Alien
