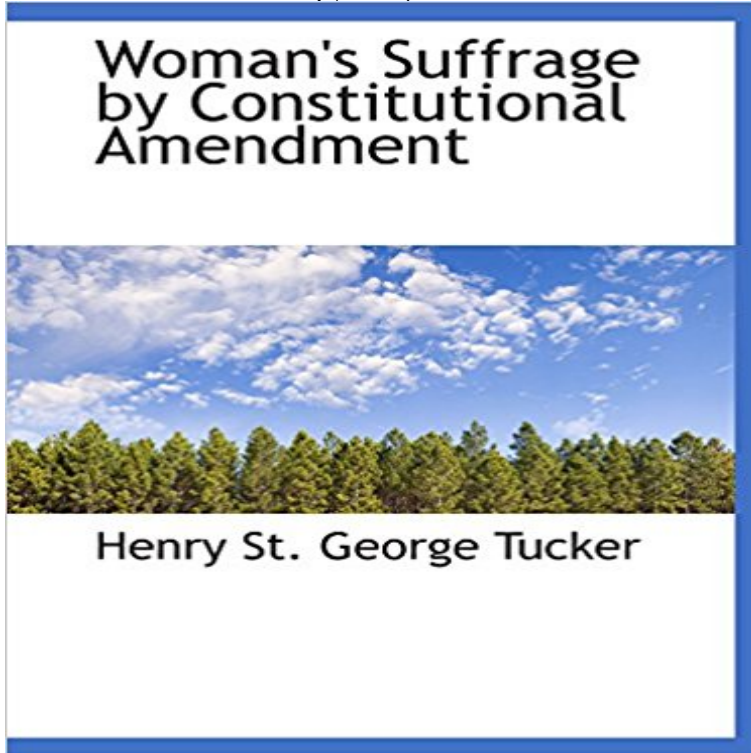


## Womans Suffrage by Constitutional Amendment
